### Jacob Dahlke

Jacob Dahlke is a clinical ethicist and the Director of the Office of Healthcare Ethics at Nebraska Medicine in Omaha, NE. Jacob is a graduate of The Bioethics Program at Union Graduate College – Mt. Sinai School of Medicine, and is currently in a PhD program at UNMC studying the intersection of healthcare ethics, structural discrimination, and health care policy. He has contributed to medical ethics in Vermont and Colorado, and is a part of the first cohort of nationally credentialed bioethicists through the American Society for Bioethics and Humanities. Jacob's primary interests in bioethics include advance care planning, the intersection of systemic racism and bioethics, and healthcare professional wellness as it relates to moral distress and moral injury.

### TOPIC: Nebraska POLST: An Introduction to Portable Medical Orders

In this session, learn about the national POLST program; identify the history within the state of Nebraska; apply the state program's recommendations for how to incorporate the Nebraska POLST form into respective facilities, systems, and other healthcare settings; and demonstrate how to use the state POLST program and NHCPA as resources and support for integrating POLST in standard practice.

Eric Davis is employed by 3M as an Advanced Wound Therapy representative for the territory including Lincoln and western Nebraska. Working in the out of hospital setting, Eric assists customers in the home health, physician office, wound care center, and skilled settings. Eric graduated in 2009 from Chadron State College with his Bachelors degree in Health Sciences, and in 2012 from the University of Nebraska Medical Center in Omaha with his Doctorate of Physical Therapy Degree. #### TOPIC: Home Health and Hospice Federal Legislative and Regulatory Updates

Join us for an update on Home Health Value Based Purchasing (HHVBP). We will cover the OASIS measures included in HHVBP, detail the claims and HHCAHPS measures, define elements of HHVBP that also directly impacts the Linear Exchange Function (LEF) calculation, discuss the 5% maximum payment impact as a result of the LEF, review the most recent released Interim Performance Reports, and review current status of HHVBP and any proposed changes.
