## Legislative Luncheon with State Senators

The Legislative Luncheon is the perfect time for impactful conversations with attentive lawmakers who can help spotlight and address ongoing issues and challenges facing in-home care.

For those who have never met their state senator, the luncheon is a great way to meet and start building a relationship. For those who know and are known by their state senator, the luncheon is a great way to have additional contact on any issues your agency is experiencing.

It will provide a great opportunity to make state senators aware that Nebraska remains waiting for federal administration's allocation of Medicaid home health funds passed via LB527 in 2025, which would increase rates by 20 percent, plus a 4 percent rural add-on.

It will also be important to address how home health agency closures, and caregiver, nurse, and therapist shortages are affecting access to in-home and home health care services; and addressing much-needed reimbursement rate adjustments and standard rates for Medicaid aged and disabled waiver personal care home care services.
